Bahrain is an archipelago of thirty-three islands in the Persian Gulf in the Middle East. It is located off the coast of Saudi Arabia and Qatar. Bahrain has a strategic location in



the Persian Gulf, where much of the Western world's petroleum must transit to reach the open ocean. The geography of Bahrain is mostly low desert plains. The government system is a constitutional

monarchy; the chief of state is the King, and the head of government is the Prime Minister. Bahrain is a member of the League of Arab States (Arab League) and the Gulf Cooperation Council (GCC).

Country rating: C - A very uncertain political and economic outlook and a business environment with many troublesome weaknesses can have a significant impact on corporate payment behavior. Corporate default probability is high. **Business Climate rating:** A4 - The business environment is acceptable. Corporate financial information is sometimes neither readily available nor sufficiently reliable. Debt collection is not always efficient and the institutional framework has shortcomings. Intercompany transactions may thus run into appreciable difficulties in the acceptable but occasionally unstable environments rated A4.

Strengths

- · Solid banking sector, developed financial hub
- More diversified economy compared with its GCC neighbours
- Large aluminium exports, making Bahrain among its largest exporters in the world
- Easy policy-making process secured once again after the November 2022 elections; no challenge to the authorities
- · Causeway to Saudi Arabia supports tourism flows
- Support of other Gulf countries plus hydrocarbon revenues

Weaknesses

- High fiscal and external breakeven oil prices, limited fiscal headroom
- High level of public debt, large external financing needs
- Fiscal and export dependence on oil and aluminum sales, exposure to volatility in commodity prices
- · Fragile political landscape
- · Dependence on foreign workers
